# 1. EDUCATIONAL OBJECTIVES AND COMPETENCES

The undergraduate study domain underlying the Master's degree study programme: Language and Literature The study programmes completed by the majority of candidates: English Language and Literature — Another Modern Language and Literature, Romanian Language and Literature — English Language and Literature, American Studies, Cultural Studies, Applied Modern Languages (with English as a major or minor) as well as other equivalent study programmes at national and international levels.

The aim of the programme and the envisaged occupations: providing the necessary skills for a teaching/research career in the field of cultural studies centred on the Anglo-American space but also in fields other than teaching — for example in cultural journalism/tourism, in public administration (spokespersons in government/European bodies or cultural promoters), in private administration (managers or employees of multinational companies), in screenwriting, in the literary market, etc.

The training objectives are defined compositionally starting from the objectives of each individual discipline and coincide with the Master's degree programme's mission, namely that of training specialists in the field of Anglo-American language and literature and in fields related to cultural and intercultural communication in this space. # 5. REQUIREMENTS FOR OBTAINING THE MASTER'S DEGREE DIPLOMA

The conditions for taking the dissertation exam are presented in the Study Completion Methodology, approved by the Senate of the University. According to this methodology, setting for the dissertation exam is conditional on the passing of all subjects included in the curriculum.

#### DISSERTATION EXAM

- 1 Period of drafting the dissertation: 3<sup>rd</sup> and 4<sup>th</sup> semesters;
- 2 Period of completion of the dissertation: the last 3 weeks of the final year;
- 3. Period of taking the dissertation exam: June-July
- 4. Number of credits for defending the dissertation: 10 credits (in addition to the 120 credits)
